Cloudflare has certainly processed directly e-mailed DMCA takedown requests for me before so there is a precedent. Otherwise, there is nothing in the DMCA that requires the use of your form. The fact that you have received my complaint MULTIPLE times now and have e-mailed back in response to this complaint demonstrates that you have received it. But for whatever reason you're choosing to be difficult to try to make me jump through hoops. As I have said, your form did not work for me despite repeated attempts to use it. And it is insulting for you to suggest that it's working fine when it is not. So again, this is absolutely my last attempt to get you to respond to this infringement for which you are impeding the removal. If you take no action now I will forward this to my legal team this week. It is more than enough of a burden to have to waste countless hours policing my own copyrights without organizations like Cloudflare running interference for copyright infringers. I am not averse to asking a federal judge to compel you to deal with these copyright infringements. And I will seek statutory damages for contributory infringement at that time.
